### SUBORDINATION AGREEMENT

This Superdination Agreement (this "Agreement"), granted this 19<sup>TH</sup> day of FEBRUARY, 2003, by CF'ASE MANHATTAN BANK USA, N.A. ("Chase") to ABN AMRO MORTGAGE GROUP, INC (the "Lender"),

#### WITNESSETH:

WHEREAS, Chase has heretcore extended a line of credit/loan to <a href="MATTHEW">MATTHEW A. SALESKI</a> (the "Borrower") pursuant to a Home Equity Line of Credit Agreement/Loan Note dated <a href="DECEMBER 7">DECEMBER 7</a>, 2001 (the "Line of Credit/Loan"); and

WHEREAS, the Borrower's obligations under the Line of Credit/Loan 0916542337 are secured by a Mortgage from the Borrower to Chase, dated DECEMBER 7, 2001, recorded DECEMBER 7, 2001 in the Land Records of COOK County, Illinois as Document 0011158914 (the "Home Equity Mortgage"), covering real property located at 930 WEST CUYLER AVE #2W, CHICAGO, IL 60313 (the "Property"); and

WHEREAS, the Lender proposes to make a loan in the original principal amount of \$269,000.00 to the Borrower (the "New Loan"), the proceeds of which will be used to repay in full all of the Borrower's original obligations secured by an original Mortgage, and to obtain a release of the lien created by the original Mortgage; and

WHEREAS, as a condition of making the New Loan, the Lender has required the Borrower to execute a mortgage on the Property securing repayment of the New Loan (the "New Mortgage"), which, upon execution and recordation of this Agreement, shall have a first lien position on the Property.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Chase hereby agrees as foilows:

- 1. Chase hereby subordinates the lien created by the Home Equity Mortgage to the lien created by the New Mortgage to the end that the lien of the New Mortgage shall be superior to the lien of the Home Equity Mortgage.
- 2. The subordination described in paragraph 1. above shall not apply to any future advance of funds to the Borrower by the Lender except for advances necessary to protect the security of the New Mortgage.
- 3. This Agreement shall be binding upon and shall inure to the benefit of Chase and the Lender and their respective successors and assigns, and any purchaser at any foreclosure sale instituted pursuant to the Home Equity Mortgage or the New Mortgage.
- 4. This Agreement shall be construed in accordance with the laws of the State of Illinois.
