This limitation of amount does not include interest, attorney fees, and other fees and charges validly made pursuant to this Security Instrument. Mortgagor represents, warrants and agrees that:

- A. Except as previously disclosed and acknowledged in writing to Lender, no Hazardous Substance is or will be located, stored or released on or in the Property. This restriction does not apply to snow quantities of Hazardous Substances that are generally recognized to be appropriate for the normal recognized and maintenance of the Property.
- B. Except as reviously disclosed and acknowledged in writing to Lender, Mortgagor and every tenant have been, are, and shall remain in full compliance with any applicable Environmental Law.
