WHEREAS, Mark A. McCollum and Jennifer L. McCollum ("Property Owner") executed a Mortgage or Deed of Trust (hereinafter the "Junior Mortgage") in favor of Subordinating Lender dated November 26, 1999 and which was recorded in the Office of Recorder of Cook County, Illinois, on December 7, 1999, as Document Number 09140475 encumbering the real estate and all buildings, structures, fixtures and improvements thereon (the "Premises") which has the street address of 411 S. 

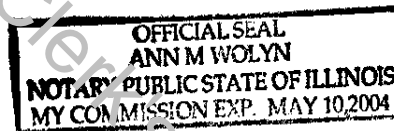
