POWER OF ATTORNEY

Revocation of the appointment of said Attorney by me shall not be effective until (1) said Attorney has received actual notice of its revocation, in the form of written notification of such revocation executed by me and delivered to said Attorney, or (2) I shall have been judicially determined to be incompetent or a disabled person and actual notice thereof shall have been received by said Attorney or I shall have died (and, in either case (1) or (2), said Attorney shall not be liable to me for any action taken by said Attorney prior to receipt of such actual notice).

The Attorney appointed hereby shall not have any obligation to perform any act on my behalf, whether to preserve or protect any of my rights or property, or otherwise. Such Attorney shall be deemed to have exercised reasonable care if she takes any action which I may request (whether or not such request is in writing, by telephone or otherwise), but failure of such Attorney to comply with any such request shall not be deemed to be (or to be evidence of) a failure to exercise reasonable care, and no failure of the Attorney to preserve or protect any of my rights or property, or to do any act with respect to the preservation of any of my rights or property (whether or not requested by me) or otherwise, shall be deemed to be (or to be evidence
