

"EXHIBIT A"

Description of a 1.999 acre tract of land situated in Lots 7 and 8 of the J. A. White Estate in Sections 9, 10, 12 and 13, Township 18 North, Range 3 East, Ouachita Parish, Louisiana, as per plat on file in Plat Book 5, Page 16, records of Ouachita Parish, Louisiana, being more particularly described as follows:

From a 1 inch iron pipe (point J) marking the Northeast corner of said Lot 7, run South 80 degrees 51 minutes 30 seconds West along the line dividing Lots 7 and 8 a distance of 436.70 feet to a 1 inch iron pipe on the Northerly right-of-way line of Pinecrest Road (50 feet wide) and the POINT OF BEGINNING; thence run Northwesterly along said right-of-way line of Pinecrest Road along the arc of a curve to the left, said curve having a radius of 257.13 feet (the long chord of which bears North 80 degrees 27 minutes 26 seconds West - 60.81 feet) for a distance of 60.95 feet, to the westerly line of that certain 3.283 acre tract of land acquired by Wilfred E. Ellis, Jr. from Henry O. Hartman, recorded in Conveyance Book 881, Page 374, records of Ouachita Parish, Louisiana; thence run North 06 degrees 04 minutes 00 seconds East along the Westerly line of said 3.283 acre tract, a distance of 577.21 feet to a point on the westerly high bank of Bayou D'Arbonne; thence run South 39 degrees 53 minutes 08 seconds East along said high bank, a distance of 354.66 feet; thence run South 33 degrees 49 minutes 54 seconds West a distance of 381.79 feet to a point on said northerly right-of-way line of Pinecrest Road; thence run northwesterly along said right-of-way line along the arc of a curve to the left, said curve having a radius of 257.13 feet (the long chord of which bears North 71 degrees 48 minutes 05 seconds West - 16.74 feet) for a distance of 16.74 feet to the POINT OF BEGINNING and containing 1.999 acres of land, more or less, TOGETHER with any property susceptible to private ownership and riparian rights lying between the above described property and Bayou D'Arbonne, having a municipal address of 636 Pinecrest Road, West Monroe, Louisiana 71291.
