As of June 21, 2002, Claimant entered into a written contract with Banc One Building Corporation, an agent of Tenant, or a person or entity authorized or knowingly permitted by Tenant to enter into contracts, under which Claimant agreed to perform certain engineering and services for the general office space improvements for the Tenant's trading floor, general offices, and critical infrastructure project and related improvements on the Real Estate in exchange for payment of an original contract sum of \$1,030,318.00, subject to increase for additional or changed work (the "Contract").

- 3. At the special instance and request of Tenant, or an agent of Tenant, or a person or entity authorized or knowingly permitted by Tenant, Claimant furnished extra and additional engineering services for the improvement of the Real Estate to the extent and value of \$232, 500.00.
- 4. The Contract was entered into and all of the services and work were performed by Claimant with the knowledge and consent of Owner. Owner, or an agent of Owner, or a person authorized by Owner, knowingly permitted the Contract, and knowingly permitted Claimant to perform all of Claimant's engineering services and work under the Contract.
- 5. Claimant completed the services and work under the Contract for which Claimant claims a lier on April 11, 2003. Claimant was discharged from completing all of the services required under the Contract by reason of Tenant's wrongful termination of Claimant's Contract.
- 6. As of the date hereof, after allowing all credits, there is presently due, unpaid and owing to Claimant, the principal sum of \$371,705.41 for which, with interest, Claimant claims a lien against the Real Estate.
- 7. Claimant hereby revotes any waiver of lien given in advance of payment for which payment was not made.
- 8. Claimant is due additional amounts for its work on the Real Estate that are not and will not be included in the Claim for Mechan cs Lien. Claimant reserves all of its rights to recover these additional amounts.
