 - (i) Borrower defaults by failing to pay in full any monthly payment required by this Security Instrument prior to or on the due date of the next monthly payment, or

- 16. Hazardous Substances. Bettev at shall not cause or permit the presence, use, disposal, storage, or release of any Hazardous Substances on or in the Property. Borrower has not executed any prior assignment of the rents and has not and will not perform any act that would prevent Lender from exercising its rights under this paragraph 17.
