THIS INDENTURE WITNESSETH, that the Grantor, MAXINE WEBB, Divorced and not since remarried

of the County of COOK and the State of ILLINOIS, for and in consideration of the sum of TEN

Dollars (\$ 10.00), in hand paid, and of other good and valuable considerations, receipt of which is hereby duly acknowledged, Convey(s) and Warrant(s) unto COLE TAYLOR BANK, a banking corporation duly organized and existing under the laws of the State of Illinois, and duly authorized to accept and execute trusts within the State of Illinois as Trustee under the provisions of a certain Trust Agreement, dated the 10th day of October, 19 90, and known as Trust Number 3662 the following described real estate in the County of Cook and State of Illinois, to wit:

All of Lot 1, all of Lot 2, Lot 3 (excepting therefrom that part thereof described as follows: Beginning at the South East Corner of Lot 3; Thence Northwesterly at right angles to the Southerly line of said Lot, a distance of 25.1 Feet; Thence North a distance of 21.62 Feet to the North Line of said Lot; Thence West along the North Line of said lot a distance of 13.0 Feet to the North West Corner thereof; Thence South along the West Line of said Lot to the South West Corner thereof; Thence Northeasterly along the Southerly Line of said Lot to point of beginning, in Gross and Counselmans Resubdivision of Lots 1, 2, 3, 4, and 5 (except the North 7 Feet thereof) in the Subdivision of Block 1 in D. In no case shall any party dealing with said Trustee, or any successor in trust, in relations to said real estate, or to whom said real estate or any part thereof shall be conveyed, contracted to be sold, leased or mortgaged by said Trustee, or any successor in trust, be obliged to see the application of any purchase money, rent or money borrowed or advanced on said real estate, or be obliged to see that the terms of this trust have been compiled with, or be obliged to inquire into the authority, necessity or expediency of any act of said Trustee, or be obliged or privileged to inquire into any of the terms of said Trust Agreement; and every deed, trust deed, mortgage, lease or other instrument executed by said Trustee, or any successor in trust, in relation to said real estate shall be conclusive evidence in favor of every person (including the Registrar of Titles of said county) relying upon or claiming under any such conveyance lease or other instrument, (a) That at the time of delivery thereof the trust created by this Indenture and by said Trust Agreement was in full force and effect, (b) that such conveyance or other instrument was executed in accordance with the trusts, conditions, and limitations contained in this Indenture and in said Trust Agreement or in all amendments thereof, if any, and binding upon all beneficiaries thereunder, (c) that said Trustee, or any successor in trust, was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument and (d) if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessor in trust.

And the said grantor(s) hereby expressly waive(s) and release(s) any and all right or benefit under and by virtue of any and all statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.
