1. Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Section 5 that repair or restoration is not economically feasible, Borrower shall promptly repair the Property if damaged to avoid further deterioration or damage. Beginning with the first Change Date, my interest rate will be based on an Index.
