ORDER

This cause coming on to be heard on petition for setting of final attorneys' fees and costs previously filed by The Law Offices of Jeffery M. Leving, Ltd., former counsel of record for Petitioner Richard Hahn, this cause having been set by previous order of this Court for 09:30 a.m., and Petitioner Richard Hahn failing to respond when the case was called in open court at 9:50 a.m.; the Court finding that it has jurisdiction of the parties and of the subject matter, and the Court being fully advised in the premises,

The Court hereby finds:

1) That The Law Offices of Jeffery M. Leving, Ltd. has fully complied with 750 ILCS 5/508(c)(3) and Cook County General Order 98 D 3 in that its fee petition contains the requisite documents of: affidavit of attorney, copies of signed retainer agreement for legal services and itemization of professional services rendered, statement of client's rights and responsibilities, and notice of alternative dispute resolution.

2) That Petitioner Richard Hahn has been given due notice of his right to opt either for or against alternative dispute resolution and has failed to do so within the additional time allowed by previous order of this Court, and thus has waived same.

3) That Petitioner has been given additional time within which to file written response to the fee petition, and has failed to do so; said Petitioner is found to be in default with respect to this fee petition.

IT IS HEREBY ORDERED:

1) The Law Offices of Jeffery M. Leving, Ltd.'s Petition for Setting Final Fees and Costs against Petitioner Richard Hahn is granted.

2) That judgment is entered in favor of The Law Offices of Jeffery M. Leving, Ltd. and against Petitioner Richard Hahn in the amount of SIX THOUSAND ONE HUNDRED FIFTY-SEVEN DOLLARS AND 50/100 (\$6,157.50).

3) This Court makes an express finding pursuant to 750 ILCS 5/508(c) that the aforesaid professional legal services were rendered pursuant to the Retainer Agreement executed by both parties thereto, were necessary and reasonable for the adequate representation of the client, and that the compensation awarded therefor is both reasonable and fair, and not unconscionable.

4) This Court makes an express finding pursuant to Illinois Supreme Court Rule 304(a) that there exists no just reason to delay either appeal or enforcement of this order.

5) The Law Offices of Jeffery M. Leving, Ltd. shall mail a copy of this order to Petitioner and to all parties and/or counsel of record entitled to notice hereof via ordinary first-class mail.
