For foreign corporations, the name must be changed in the state or country of incorporation by articles of amendment filed there, and an Application ior Amended Certificate of Authority, together with a certified copy of the amendment, must be filed pursuant to Section 113.40.

Note 2:

If a foreign perporation's true name was not available for use when the original certificate of authority was issued and is still not available, the corporation had to adopt an assumed corporate name for use in Illinois. When reinstating, an Application For An Assumed Corporation Name, pursuant to Section 104.15, must accompany the reinstatement application.
