If substantially equivalent Mortgage Insurance coverage is not available, Borrower shall cuntinue to pay to Lender the amount of the separately designated payments that were due when the insurance coverage ceased to be in effect. (B) The Index

Beginning with the first Change Date, my interest rate will be based on an Index. The "Index" is the weekly average yield on United States Treasury securities adjusted to a constant maturity of one year, as made available by the Federal Reserve Board. The most recent Index figure available as of the date 45 days before each Change Date is called the "Current Index."

(C) Calculation of Changes
