The Manorhomes of Somerset Park Condominium Association hereby amends Article 5 of the Declaration of Condominium Ownership and of Covenant, Conditions, Easements and Restrictions for The Manorhomes of Somerset Park Condominiums No. 101 E recorded as document number 25711995. Article 5 is amended to state as follows: "No unit shall be leased for transient, hotel purposes of any kind or rental purposes except a unit owner may rent their unit to an individual related to the unit owner in any of the following ways by blood or adoption: mother, father, son, daughter, grandparent, sibling, great-grandparent, uncle, aunt, nephew, niece, first cousin, great-uncle or great-aunt, or is the spouse of such a relative, or is the step-father, step-mother, step-brother, step-sister, step-son or step-daughter."
