Lender may require Borrower to pay a one-time charge for a real estate tax verification and/or reporting service used by Lender in connection with this Loan.

5. Property Insurance. Borrowershall keep the improvements now existing or hereaftererected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lenderrequires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lenderrequires. What Lenderrequires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrowersubject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. - 7. Preservation, Maintenance and Protection of the Property; Inspections. Borrowershall not destroy, damage or impair the Property, allow the Property to deteriorateor commit waste on the Property. Whetheror not Borrowers residing in the Property, Borrowershall maintainthe Property in order to prevent the Property from deterioratingor decreasing in value due to its condition. Unless it is determined pursuant to Section 5 that repair or restoration is not economically feasible, Borrower shall promptly repair the Property if damageato avoid further deteriorationor damage. If insurance or condemnationproceeds are paid in connection with damageto, or the taking of, the Property, Borrower shall be responsible for repairing or restoring the Property only if Lenderhas released proceeds for such purposes. Material representation sinclude, but are not limited to, representation soncerning Borrow, so cappancy of the Property as Borrower's principal residence.
- 9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. If (a) Borrowerfails to perform the covenants and agreements contained in this Security Instrument, (b) there is a legal proceedingthat might significantly affect Lender's interest in the Property and/or rights under this Security Instrument(such as a proceeding in bankruptcy, probate, for condemnation forfeiture, for enforcementof a lien which may attain priority over this Security Instrumentor to enforce laws or regulations), or (c) Borrowerhas abandoned the Property, then Lendermay do and pay for whatever is reasonable or appropriate to protect Lender's interest in the Property and rights under this Security Instrument, including protecting and/or assessing the value of the Property, and securing and/or repairing the Property.
