And the Grantor, for itself, and its successors and assigns, does covenant, promise and agree, to and with the Grantee, its successors and assigns, that during the period that Grantor has owned title to Real Estate, it has not done or suffered to be done anything whereby the Real Estate hereby granted are, or may be, in any manner encumbered or charged except for those items listed on Exhibit A attached hereof (the "Permitted Exception"); and that, subject to the Permitted Exceptions, the Grantor will warrant and forever defend the Real Estate.

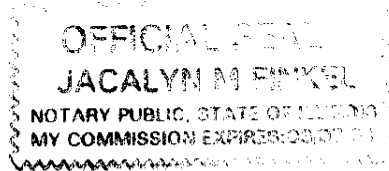

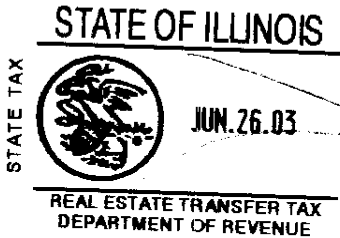

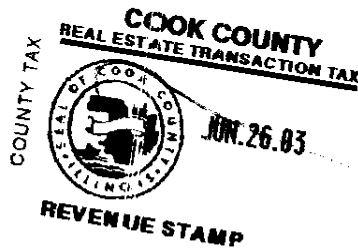
