Securing the Property includes, but is not limited to, entering the Property to make repairs, change locks, replace or board up doors and windows, drain water from pipes, eliminate building or other code violations or dangerous conditions, and have utilities turned on or off. Although Lender may take action under this Section 9, Lender does not have to do so and is not under any duty or obligation to do so. It is agreed that Lencer locurs no liability for not taking any or all actions authorized under this Section 9.

Any amounts disbursed by Lender under this section 9 shall become additional debt of Borrower secured by this Security Instrument. Mortgage Insurance reimburses Lender (or any entity that purchases the Note) for certain losses it may incur if Borrower does not repay the Loan as agreed. Borrower is not a party to the Mortgage Insurance.

and (c) any condition caused by the presence, use or release of a Hazardous Substance which adversely affects the value of the Property.
