

Payments are deemed received at the location designated in Note or at such other location as may be designated by Lender in accordance with the notice provisions in Section 15. Lender may require payment or partial payment if the payment is insufficient to bring the Loan current without waiver of any rights hereunder or prejudicial to its rights to refuse such payment or part of it, payments in the future, but Lender is not obliged to apply such payments at the time such payments are accepted. If each Periodic Payment is applied as of its scheduled due date, then Lender need not pay interest on unpaid funds. Lender may hold such unpaid funds until Borrower makes payment to bring the Loan current. If Borrower does not do so within a reasonable period of time, Lender shall either apply such funds or return them to Borrower. If not applied earlier, such funds will be applied to the outstanding principal balance under the Note immediately prior to foreclosure. No offset from making payments due under the Note and this Security Instrument or performing the covenants and agreements secured by this Security Instrument.

2. Application of Payments or Proceeds. 3. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts

Leender may require Borrower to pay a one-time charge for a real estate tax certification and/or reporting service used by Leender in connection with this Loan.

Borrower shall promptly discharge any lien which has priority over this Security Instrument unless Borrower: (a) agrees in writing to the payment of the obligation secured by the lien in a manner acceptable to Lender, but only so long as Borrower is performing such agreement; (b) commutes the lien in good faith by, or defers it against enforcement of the lien in, legal proceedings which in Lender's opinion operate to prevent the enforcement of the lien while those proceedings are pending, but only until such proceedings are concluded; or (c) secures from the holder of the lien an agreement satisfactory to Lender superdiminishing the lien to this Security instrument. Borrower shall pay all fees, and Assessments, if any. To the extent that these items are Escrow Items, Borrower shall bear them in the manner provided in Section 3.

Upon payment in full of all sums secured by this Security Instrument, Lender shall promptly refund to Borrower's Fund held by Lender.

If there is a surplus of Funds held in escrow, as defined under RESPA, Lender shall account to Borrower for the excess funds in accordance with RESPA. 8. Borrower's Loan Application. Borrower shall be in default if, during the Loan application process, Borrower or any persons or entities acting at the direction of Borrower or with Borrower's knowledge or consent gave materially false, misleading, or inaccurate information or statements to Lender (or failed to provide Lender with material information) in specifying such reasonable cause.

Lender shall give Borrower notice at the time of or prior to such an interior inspection if it has reasonable cause, Lender may inspect the interior of the improvements of the Property. Lender or its agent may make reasonable entries upon and inspectors of the Property.

Lender may disburse proceeds for the repairs and restoration in a timely payment of Borrower's obligation to repair or restore the Property, Borrower is not relieved of Borrower's obligation for sufficient progress payments as the work is completed. If the insurance or condemnation proceeds are not sufficient to repair or restore the Property only if Lender has released proceeds for such purposes. 




