THIS CAUSE COMING to be heard on the set call, the Court having jurisdiction over the parties and subject matter and being fully advised in the premises:

IT IS HEREBY ORDERED THAT:

1. The judgment(s) hereby entered on the date(s) of 1/22/03 in the amount of \$ 1,500.00 plus \$60 court costs for a total of \$ 1,560.00 against Defendant(s) Maria DeMoran + Jose Barrera shall stand as final judgment and that leave to enforce said judgment is granted Plaintiff, City of Chicago, instanter.
