ASSIGNMENT AND ASSUMPTION OF PROMISSORY NOTE AND MORTGAGE

THIS ASSIGNMENT AND ASSUMPTION OF PROMISSORY NOTE AND MORTGAGE (this "Assignment") is executed as of this 27th day of May, 2003 by and between LAWNDALE COMMUNITY SCHOOL, an Illinois corporation exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code ("Assignor"), and the LAWNDALE EDUCATIONAL AND REGIONAL NETWORK CHARTER SCHOOL, an Illinois corporation exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code ("Assignee").

RECITALS

- A. Assignor, as seller, and Assignee, as purchaser, are parties to that certain Asset Transfer Letter Agreement dated as of May 28, 2003 (the "Agreement"), pursuant to which Assignor agreed to sell and Assignee agreed to purchase certain assets of Assignor, including the land legally described in Exhibit A attached hereto and made a part hereof (the "Premises").
- B. Assignor is party to that certain Mortgage (the "Mortgage") dated as of May 15, 1997 and recorded May 19, 1997 as document number 97350425 (the "Mortgage"), made by Assignor to Illinois Facilities Fund, an Illinois not-for-profit corporation ("IFF") to secure that certain Promissory Note dated May 15, 1997 in the amount of \$300,000 the "Note"). Assignor is also a party to the Modification Agreement pertaining to the Mortgage recorded September 28, 1999 as document number 99915326 ("Modification Agreement").
- C. Pursuant to the terms of the Agreement, Assignor wishes to assign to Assignee and Assignee wishes to assume, all of Assignor's right, title, interest, liabilities and obligations in and under the Mortgage, Note and Modification Agreement.
