SUBORDINATION OF MORTGAGE



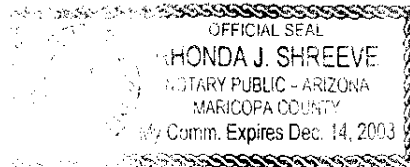
