MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

The interest rate is hereby changed from Lender's Reference Rate Floating to 90-day LIBOR Rate plus 250 basis points. The term of the note is hereby changed from 5-year/294 months amortization to 5-year/25-year amortization. The maturity Date of November 1, 2007 is hereby extended to May 1, 2008 and the payment has been modified as further described in the payment section of the Change in Terms Agreement. All other terms and provisions of the loan documents and related documents shall remain in full force and effect.
