Grantor shall procure and maintein policies of fire insurance with standard extended coverage endorsements on a replacement basis to the full insurable value covering all Improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee clause in favor of Lender.
