If the Unit has not been conveyed or re-occupied by the Unit Owner at the expiration of the one-year period, then at least thirty (30) days prior to the expiration of the one-year period, the Unit Owner may apply to the foord of Directors for a six (6) month extension. Any application for an extension must be in writing and set forth the reasons for requesting the extension. The Beard of Directors can consider those requests at a meeting where the Unit Owner applying for the extension may be present and given an opportunity to be heard.

Notwithstanding any provisions herein to the contrary, a Unit Owner's right to lease his Unit or cause it to be occupied by a person other than the Unit Owner or his immediate family in accordance with the provisions of this Section shall be exercised only once during his ownership of said Unit and any subsequent lease to, or occupancy of, said Unit by a person other than the Unit Owner or his immediate family is prohibited.

If any lease to, or occupancy of, a Unit by a person other than an Owner
