The contract scheduled performance of the work between April 21, 2003 and April 24, 2003 for a contract amount of Sixteen Thousand Dollars and 00/100 (\$16,000.00).
- 4. Claimant was thereafter required to perform additional services in the amount of \$5,875.00 on the Property from April 21, 2003 through April 25, 2003. Claimant last completed work on the Property on April 25, 2003. Claimant was also required to provide overtime services on the Property during this time period. All additional and overtime services were requested and approved by the Subcontractor.
- 5. To date, Claimant has been paid Twelve Thousand Two Hundred Forty Four Dollars and 00/10 for services provided on the Property (\$12,244.00). After all due credits are given to Subcontractor, a balance remains due and owing to Claimant in the amount of Nine Thousand Six Hundred Thirty One and 00/100 Dollars (\$9,631.00).
- 6. There is currently due, unpaid and owing to Claimant for the above described work the sum of Nine Thousand Six Hundred Thirty One Dollars and 00/00 (\$9,631.00), plus interest, attorneys fees and court costs. Claimant hereby claims a Mechanic's Lien against the Property and all improvements made thereon in the amount of Nine Thousand Six Hundred Thirty One Dollars and 00/00 (\$9,631.00).
