**2. Application of Payments or Proceeds.** Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. Such payments shall be applied to each Periodic Payment in the order it became due. Any remaining amounts shall be applied first to late charges, second to any other amounts due under this Security Instrument, and then to reduce the principal balance of the Note.

Payments are deemed received at the location designated by Lender when received at the location specified in the Note or at such other location as may be designated by Lender in accordance with the notice provisions in Section 15. Lender may return any payment or partial payment in the payment of principal payments are insufficient to bring the Loan current. Lender may accept any payment or partial payment to bring the Loan current. Lender may waive or any rights hereunder or preclude to its rights to refuse such partial payments in the future, but Lender is not obliged to accept such payments at the time such payments are accepted. **5. Property Insurance.** Borrower shall keep the improvements now existing or  
hereafter erected on the Property insured against loss by fire, hazards included within the term  
"extended coverage," and any other hazards including, but not limited to, earthquakes and  
floods, for which Lender requires insurance. This insurance shall be maintained in the amounts  
and/or reporting service used by Lender in connection with this Loan.
