Any application of payments, insurance proceeds, or Miscellaneous Proceeds to principal due under the Note shall not extend or postpone the due date, or change the amount, of the Periodic Payments.

3. Funds for Escrow Items. Borrower shall pay to Lender on the day Periodic Payments are due under the Note, until the Note is paid in full, a sum (the "Funds") to provide for payment of amounts due for: (a) taxes and assessments and other items which can attain priority over this Security Instrument as a lien or encumbrance on the Property; (b) leasehold payments or ground rents on the Property, if any; (c) premiums for any and all insurance required by Lender under Section 5; and (d) Mortgage Insurance premiums, if any, or any sums payable by Borrower to Lender in lieu of the payment of Mortgage Insurance premiums in accordance with the provisions of Section 10. 4. Charges; Liens. Borrower shall pay all taxes, assessments, charges, fines, and impositions attributable to the Property which can attain priority over this Security Instrument, leasehold payments or ground rents on the Property, if any, and Community Association Dues, Fees, and Assessments, if any. To the extent that these items are Escrow Items, Borrower shall pay them in the manner provided in Section 3.

Borrower: (a) agrees in writing to the payment of the obligation secured by the lien in a manner acceptable to Lender, but only so long as Borrower is performing such agreement; (b) contests the lien in good faith by, or defends against enforcement of the lien in, legal proceedings which in Lender's opinion operate to prevent the enforcement of the lien while those proceedings are pending, but only until such proceedings are concluded: or (c) secures from the holder of the lien an agreement satisfactory to Lender subordinating the lien to this S curity Instrument. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower. Unless Lender and Borrower otherwise agree in writing, any insurance proceeds, whether or not the underlying insurance was required by Lender, shall be applied to restoration or repair of the Property, if the restoration or repair is economically feasible and Lender's security is not lessened. During such repair and restoration period, Lender shall have the right to hold such insurance proceeds until Lender has had an opportunity to inspect such Property to ensure the work has been completed to Lender's satisfaction, provided that such inspection shall be undertaken promptly. Lender may disburse proceeds for the repairs and restoration in a single payment or in a series of progress payments as the work is completed. 8. Borrower's Loan Application. Borrower shall be in default if, during the Loan application process, Borrower or any persons or entities acting at the direction of Borrower or with Borrower's knowledge or consent gave materially false, misleading, or inaccurate information or statements to Lender (or failed to provide Lender with material information) in connection with the Loan. Material representations include, but are not limited to, representations concerning Borrower's occupancy of the Property as Borrower's principal residence.

9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. IF ESCROW AMOUNTS ARE DUE WITH A SKIPPED PAYMENT, THESE AMOUNTS WILL BE ADVANCED BY THE LENDER AS ADDITIONAL PRINCIPAL. THE NOTE ALSO PROVIDES THAT UNPAID INTEREST MAY BE ADDED TO PRINCIPAL AND THAT INTEREST WILL BE CHARGED ON THAT INTEREST. SUCH ADDITIONAL FUTURE ADVANCES OF INTEREST AND ESCROW AMOUNTS COULD CAUSE THE PRINCIPAL AMOUNT DUE UNDER THE NO'.F TO CHANGE, WITHIN THE LIMITS STATED IN THE NOTE. ALL SUCH FUTURF ADVANCES SHALL BE SECURED BY THE SECURITY INSTRUMENT WITH THE SAME LIEN PRIORITY AS IF SUCH FUTURE ADVANCES WERE MADE ON THE DATE OF THE NOTE AND THE SECURITY INSTRUMENT.

B. FUTURE ADVANCES

The following provision is added to the Security Instrument:

Future Advances. Pursuant to the PaymentPower Option contained in the Note, the Lender is obligated to make certain future advances. Any and all such future advances will be secured by this Security Instrument with the same lien proving as if such future advances were made on the date of the Note and this Security Instrument. However, at no time small the maximum principal amount of the indebtedness secured by this Security Instrument exceed the amount stated in the third sentence of the definition of "Note" set forth in this Security Instrument.

C. LOAN CHARGES

Uniform Covenant 14 of the Security Instrument is replaced in its entirety by the following:

14. Loan Charges. Lender may charge Borrower (ee.s for services performed in connection with Borrower's default, for the purpose of protecting Lender's interest in the Property and rights under this Security Instrument, including, but not limited to, attorneys' fees, property inspection and valuation fees. In regard to any other fees, the absence of express authority in this Security Instrument to charge a specific fee to Borrower shall not be construed as a prohibition on the charging of such fee. Lender may not charge fees that are expressly prohibited by this Security Instrument or by Applicable Law.

If the Loan is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the Loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded 1 erm tted limits will be refunded to Borrower. If Applicable Law is finally interpreted so as to render the cha ging of, or contracting for, interest on interest or the required charge to exercise the PaymentPower Option usuaious or in violation of Applicable Law, then (i) any interest paid by Borrower in excess of that permitted by Applicable Law will be refunded to Borrower, (ii) the provisions of the Note immediately will be deemed reformed, (iii) Borrower's right to exercise the PaymentPower Option will terminate, and (iv) the amounts thereafter collectible under the Note will be reduced, without the necessity of the execution of any new documents, so as to comply with Applicable Law. Lender may choose to make any refund required by this Section 14 by reducing the principal owed under the Note or by making a direct payment to Borrower. If a refund reduces principal, the reduction will be treated as a partial prepayment without any prepayment charge (whether or not a prepayment charge is provided for under the Note). Borrower's acceptance of any such refund made by direct payment to Borrower will constitute a waiver of any right of action Borrower might have arising out of such overcharge.
