The most recent Index figure available as of the first business day of the month immediately preceding the month in which the Change Date occurs is called the "Chare at Index".

If the Index is no longer available, the Note Holder will choose a new index that is based upon comparable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding TWO & THREE-QUARTERS percentage points (2.750 %) to the Current Index. Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change

(D) Limits on Interest Rate Changes
