

SUBORDINATION OF MORTGAGE

THE SUBORDINATION OF MCRTGAGE dated June 16, 2003 is made and executed among Cornerstone National Bank & Trust Company ("Mortgagee/Sadordinating Bank"); and Cornerstone Mortgage Group Ltd., Its Successors and/or Assigns ("Lender").

SUBORDINATED INDEBTEDNESS. Mot gagee has extended the following described financial accommodation(s) (the "Subordinated Indebtedness") to Timothy B. Notto'l and Susan E. Nottoli ("Borrower").

A Note in the Sum of \$110,000 dated December 7, 2001 with a Maturity of December 7, 2011, in favor of Cornerstone National Bank and Trust Company ("Norvagagee"), and modified with a Credit Agreement and Disclosure Change In Terms Agreement dated June 16, 2003 reducing principal amount of said note to be \$75,000.

SURBORDINATED MORTGAGE. The Subordinated Indebtedness is secured by a mortgage dated December 7, 2001, and recorded January 14, 2002 from Borrower to Mortgagee (the "Subordinated Mortgage") on certain premises in Cook County, Illinois.

REAL PROPERTY DESCRIPTION. The Subordinated Mortgage covers the following real property located in Cook County, State of Illinois:

LOT IN BARTEL'S RESUBDIVISION OF LOTS 15, 16, 17, 18, 24 ANI 25 IN JOEL WOOD'S SUBDIVISION OF BLOCK "Z" IN PALATINE IN THE EAST ½ OF THE NORTHVEST ¼ OF SECTION 14, TOWNSHIP 42 NORTH, RANGE EAST JT. THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

The Real Property or its address is commonly known as 308 North Freemont, Palatine, IL 60067. The Real Property tax identification number is 02-14-303-009-0000.

NOW THEREFORE THE PARTIES TO THIS SUBORDINATION STATE THE FOLLOWING:

SUBORDINATION. The Subordinated Mortgage and the Subordinated Indebtedness secured by the Subordinated Mortgage is and shall be subordinated in all respects to the Lender's Lien and the Superior Indebtedness, and it is agreed the Lender's Lien shall be and remain, at all times, prior and superior to the lien of the Subordinated Mortgage. Furthermore, Lender is about to lend to Borrower Two Hundred Twenty Six Thousand Dollars 00/100 (\$226,000.00) to pay the indebtedness of Borrower to Lender (or other first mortgage to be paid off) and to obtain the release of the first mortgage in favor of Lender and in connection therewith, Borrowers shall give to Lender a Mortgage to secure the loan in the amount of \$226,000.00 and dated June 16, 2003

DEFAULT BY BORROWER. If Borrower becomes insolvent or bankrupt, this Subordination shall remain in full force and effect.

MISCELLANEOUS PROVISIONS. The following miscellaneous provisions are a part of this Subordination:

Existing First Mortgage: If the existing first mortgage in favor of Lender (or other lending institution), as described above, is released in full, then the mortgage in favor of Subordination Bank, shall be and is hereby subjected and subordinated and shall become in all respects subordinate and junior to the lien of the mortgage given by Borrower to Lender as collateral for the loan to pay off the existing first mortgage and to replace it with a mortgage in favor of Lender.

Lender agrees to not increase the principal sum under the mortgage to which the Subordinating Principal Increases: Bank hereby subordinates or to make additional advances of principal under the mortgage, without the written consent of Subordinating Bank. Notwithstanding, Subordinating Bank acknowledges that Lender has a right to interest on the unpaid principal balance of the mortgage, penalties for nonpayment thereof, and a right to recover amount expended for payment of real estate taxes, hazard insurance and costs incident to foreclosure and such items are included in this subordination.

Amendments: What it ritten in this Subordination is Mortgagee's entire agreement with Lender concerning the matters covered by this Subording nor. To be effective, any change or amendment to this Subordination must be in writing and must be signed by whoever will be bound or obligated by the change or amendment.

Authority: The person who signs in Subordination as or on behalf of Mortgagee represents and warrants that he or she has authority to execute this Subordination and to subordinate the Subordinated Indebtedness and the Mortgagee's security interest in the Borrower's property, if any.
