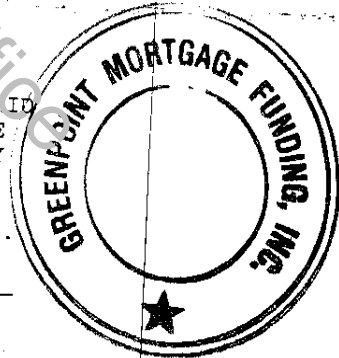
The undersigned, Linda Story-Daw, Vice President of GreenPoint Mortgage Funding, Inc. being duly sworn, upon oath, states as follows:

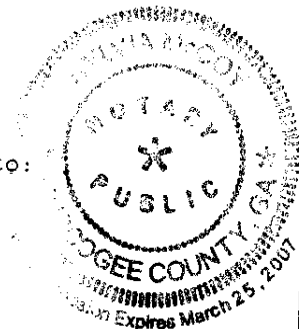
