AGREED ORDER

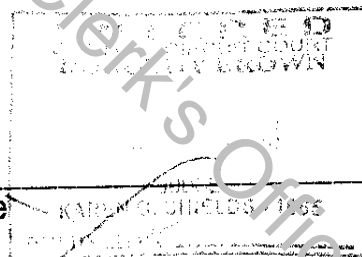
This matter coming on to be hear upon the status call, Court and Counsel being fully advised in the premise.
