MEMORANDUM OF AGREEMENT

March 6, 2003

This Memorandum of Agreement (this "Memorandum") is entered into as of November ____; 2002, by and bety eer Newberry Plaza Condominium Association, Inc., an Illinois not-for-profit corporation ("Licensor"), and TVMAX Illinois, Inc., a Delaware corporation ("Licensee").

- A. Licensor is the owner of real property known as Newberry Plaza Condominiums located at 1030 North State Succet. Chicago, Illinois 60610, and more particularly described on <u>Exhibit "A"</u> attached hereto and incorporated herein by reference (the "Property").
- B. Licensor and Licensee have entered into that certain Rooftop License Agreement (the "Agreement"), dated as of the date becof pursuant to which Licensor has granted to Licensee a right of access over the rooftops, the Equipment Room, and those portions of the Property necessary to install, operate and maintain Licensee's equipment (the "Equipment") on the terms and conditions set forth in the Agreement.
- C. The Agreement shall run with the land and shall be binding upon and inure to the benefit of the parties hereto and their successors and assigns.
- D. The Agreement and this Memorandum constitute the entire agreement between the parties, and shall supersede all other contemporaneous or prior oral and written agreements between the parties relating to the subject matter of the Agreement. The Agreement may only be modified or a mended by written agreement executed by the parties.
- E. The Agreement shall be deemed effective upon the date of bereof and shall continue in full force and effect for an initial term of five (5) years. Thereafter, the Agreement shall be renewed automatically for three (3) additional successive five (5) year terms unless terminated pursuant to the terms of the Agreement.
 - F. The terms of the Agreement are incorporated herein by this reference.


