SUBORDINATION AGREEMENT

THIS INDENTURE made this 7th day of July, 2003.

WHEREAS, National City, a corporation, with principal offices located in Miamisburg, Ohio, has heretofore made a loan secured by a mortgage on the hereinafter described real estate located in Cook County, Illinois, which mortgage was made by Kenneth J. AND WHEREAS, National City Mortgage Co. proposes to make a further mortgage loan to Kenneth J. Wright and Jean M. Wright, in the amount of \$152,700.00, which mortgage lien shall be evidenced by a certain promissory note and secured by a mortgage upon the same above-described property in Cook County, Illinois.

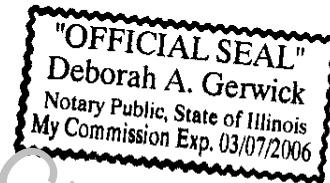
