This cause coming to be heard on Defendant's, GNI of Hoffman Estates, LLC ("GNI"), Motion for Summary Judgment against Illinois Construction Services, Inc. ("ICS"), the Court being advised in the premise, and due notice having been given, the Court makes the following findings and enters the following order:

#### **FINDINGS**

1. GNI is an Illinois limited liability company organized and existing under the laws of the State of Illinois, with its principal place of business located at 3208 S. Alpine Road,

Rockford, Illinois. GNI is, and at all relevant times was, the owner of certain real property commonly known as 1550-1590 Algonquin Road, Hoffman Estates, Illinois (the "Property").

- 2. ICS is an Illinois corporation engaged in the construction industry as a subcontractor having its principal place of business at 2433 Reeves Road, Joliet, Illinois, who has an interest in the Property by virtue of a Mechanic's Lien filed in Cook County on July 19, 2002 as Document Number 0020703622.
- 3. On March 19, 2003, GNI served ICS, by certified mail, with a written demand that suit be commenced within 30 days, by ICS, to enforce its lien or cause its answer to be filed in the captioned case, pursuant to Section 24 of the Illinois Mechanics Lien Act (the "Act").
- 4. ICS has not filed a complaint to foreclose its mechanics lien or filed an answer in the A&A case, as required by Section 34 of the Act.
- 5. On May 8, 2003, GNI filed its Cross-Claim for Declaratory Judgment against ICS to declare any interest claimed by ICS in the Property extinguished and forfeit.
- 6. On May 29, 2003 GNI filed a Motion for Summary Judgment against ICS, and properly served notice of that motion on ICS by both regular and certified mail.
- 7. The hearing on that motion was continued to July 22, 2003, and GM properly served ICS with notice of that continuance by both regular and certified mail.
- 8. ICS has failed to appear at the hearing on GNI's Motion for Summary Judgment, or at any other proceedings in this case.

### Accordingly, IT IS HEREBY ORDERED,

- Summary Judgment is entered in favor of GNI and against ICS for declaratory 1. judgment on ICS claim under the Illinois Mechanic's Lien Act.
- Pursuant to Section 34 of the Illinois Mechanics Act, the failure of ICS to commence 2. suit to enforce its lien extinguishes and forfeits any such lien ICS claimed on the Property.
- Accordingly, the Mechanics Lien filed by ICS against certain real property commonly 3. known as 1550-1590 Algonouin Road, Hoffman Estates, Illinois, and recorded as a Document Number 0020703622 with the Cook County Recorder of Deeds is hereby declared null and void, Collination and is extinguished.
