ASSIGNMENT AND ASSUMPTION AGREEMENT

- Borrower has transferred title ic rhe real property described on Exhibit "A" to Successor Borrower by that certain Warranty Seedsdated April 7, 2003.
- 2) Successor Borrower and Borrower desire the consent of Lender to such assignments, transfers, and conveyances.
- 3) Successor Borrower hereby agrees to be bound by the terms, conditions and provisions of the Loan Documents previously entered into between Borrower and Lender (including the obligation to make payments under the Note), and assumes, ratifies and confirms all duties, obligations, representations, warranties and covenants of the Lean Documents.
- 4) This Agreement shall be governed by, and construed in accordance with the internal laws of the State of Illinois.
- 5) This Agreement shall inure to the benefit of Lender's successors and assigns, and shall be binding upon the respective heirs, executors, administrators, successors and assigns of Borrower and Successor Borrower.
