# ASSIGNMENT AND ASSUMPTION AGREEMENT

NOW, THEREFORE. for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties state as follows:

- Borrower has transferred title to the real property described on Exhibit "A" to Successor Borrower by that certain Warranty Der did sted, April 7, 2003.
- 2) Successor Borrower and Borrower desire the consent of Lender to such assignments, transfers, and conveyances.
- 3) Successor Borrower hereby agrees to be bound by the 'erm's, conditions and provisions of the Loan Documents previously entered into between Borrower and Lender (including the obligation to make payments under the Note), and assumes, retribes and confirms all duties, obligations, representations, warranties and covenants of the Loan Documents.
- 4) This Agreement shall be governed by, and construed in accordance with, the internal laws of the State of Illinois.
- 5) This Agreement shall inure to the benefit of Lender's successors and assigns, and shall be binding upon the respective heirs, executors, administrators, successors and assigns of Borrower and Successor Borrower.
