LEGAL DESCRIPTION:

PARCEL 1:

A STRIP OF LAND APPROXIMATELY 50 FEET IN WIDTH, LOCATED IN THE EAST 1/2 OF THE SOUTHWEST 1/4 OF SECTION 33, TOWNSHIP 33 NORTH, RANGE 14 EAST, AT THE THIRD PRINCIPAL MERIDIAN, BEING IN CHICAGO, COOK COUNTY, ILLINOIS, AS FOLLOWS: COMMENCING AT THE NORTHWEST CORNER OF THE INTERSECTION OF RACINE AVENUE AND SCHOOL STREET IN CHICAGO; THENCE WEST ALONG THE NORTH LINE OF SCHOOL STREET FOR A DISTANCE OF APPROXIMATELY 344 FEET TO THE POINT OF BEGINNING; THENCE NORTH 24 DEGREES 45 MINUTES EAST, MORE OR LESS, FOR A DISTANCE OF APPROXIMATELY 530 FEET TO THE WEST LINE OF RACINE AVENUE; THENCE NORTH ALONG THE WEST LINE OF RACINE AVENUE FOR A DISTANCE OF APPROXIMATELY 109 FEET; THENCE SOUTH 75 DEGREES 45 MINUTES WEST, MORE OR LESS, FOR A DISTANCE OF APPROXIMATELY 674 FEET TO THE NORTH LINE OF SCHOOL STREET; THENCE EAST ALONG THE NORTH LINE OF SCHOOL STREET FOR A DISTANCE OF APPROXIMATELY 60 FEET TO THE POINT OF BEGINNING, BEING PART OF THAT PROPERTY CONVEYED BY MAX SKINNER AND ELIZABETH W. SKINNER TO CHICAGO AND EVANSTON RAILROAD COMPANY (GRANTOR'S PREDECESSOR IN INTEREST) BY DEED DATED NOVEMBER 16, 1882 AND RECORDED DECEMBER 13, 1882 IN BOOK 1376, PAGE 497. (EXCEPT FROM SAID STRIP OF LAND THE SOUTHWESTERLY 100.0 FEET THEREOF AS MEASURED ON THE EASTERLY AND WESTERLY LINES THEREOF, AND EXCEPT THAT PART THEREOF LYING NORTH OF A LINE DRAWN PERPENDICULAR TO THE WEST LINE OF RACINE AVENUE THROUGH A POINT THEREIN 42.56 FEET SOUTH OF THE 100.0 NORTHERLY CORNER OF SAID STRIP) IN COOK COUNTY, ILLINOIS.

ALL OF LOTS 24, 25, 26, 27, 28 AND LOT 'A' IN BLOCK 5 IN WILLIAM C. COONEY'S SUBDIVISION OF THAT PART OF THE SOUTH PART 1/4 OF THE SOUTHWEST 1/4 OF SECTION 28, TOWNSHIP 33 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING WEST OF THE CITY OF CHICAGO, EVANSTON AND LAKE SUPERIOR RAILROAD.
