into the 1st day of August, 2003, as an amendment to that certain Declaration of Condominium for the Provincial Manor Condominium Association.

THEORDING FEE 701 WITNESSETH:

Provincial Manor Condominium Association was recorded in the Office of the Recorder of Deeds of Cook County as Document No. 21576919 ("Declaration"), and

WHEREAS, the Provincial Manor Condominium Association (hereinafter referred to as "Association") is the assignee of the developer's rights as set forth and described in the Declaration; and

WHEREAS, pursuant to Section 17 of the Declaration, the Declaration may be amended by the affirmative vote of Voting Members representing at least seventy-five percent (75%) of the Votes of Owners evidenced in writing. No amendment is effective until recorded; and

WHEREAS, said instrument has been approved by Voting Members representing at least seventy five percent (75%) of the Votes of Owners, and the ballots/retitions are attached hereto; and

WHEREAS, the Board of Directors has certified this Amendment, as evidenced by the certification attached hereto as Exhibit B.

p. <u>Leasing of Units</u>.

- 1. In order to maintain the quality of life and property values, the objective of the Association is to promote and encourage Unit Owners to reside on the premises. Following the effective date of this Amendment and subject to the provisions contained herein, owners shall be prohibited from leasing a unit.
- 2. A Unit Owner may apply for a one year hardship waiver in the following manner:
 - (a) The Unit Owner must submit a request in writing to the Board of Directors requesting a one year hardship waiver of the lease restriction setting forth the reasons why they are entitled to same.
 - (b) If, based on the data supplied to the Board of Directors by the Unit Owner, the Board finds in its sole discretion that a reasonable hardship exists, the Board may grant a one year waiver. Any lease entered into shall be in writing and for a period of one year. The lease must also contain a provision that failure by the tenant or the Unit Owner to abide by the Rules and Regulations of the Association may, in the discretion of the Board of Directors, result in termination of the lease by the Board of Directors. At decisions of the Board shall be final.
 - (c) Copies of all eases must be submitted to the Board within ten (10) days after execution and prior to occupancy.
 - (d) All tenants shall acknowledge in writing that they have received copies of the rules and regulations of the Association and a copy of the written receipt shall be submitted to the Board of Directors.
- 3. The effective date of this Amendment is the date of recording with the office of the Recorder of Deeds of Cook County.
- 4. Any Unit being leased out in violation of this Amendment or any Owner found to be in violation of the Rules and Regulations adopted by the Board of Directors may be subject to a flat or daily fine to be determined by the Board of Directors upon notice and an opportunity to be heard.
- 5. In addition to the authority to levy fines against the Owner for violation of this Amendment or any other provision of the Declaration, By-Laws or Rules and Regulations, the Board shall have all rights and remedies, including but not limited to the right to maintain an action for possession against the Owner and/or their tenant, under 735 ILCS 5/9-111, an action for injunctive and other equitable relief, or an action at law for damages.
- 6. Any action brought on behalf of the Association and/or the Board of Directors to enforce this Amendment shall subject the Owner to the payment of all costs and attorneys' fees at the time they are incurred by the Association.

- All unpaid charges as a result of the foregoing shall be deemed to 7. be a lien against the Unit and collectible as any other unpaid regular or special assessment, including late fees and interest on the unpaid balance.
- This Amendment shall not prohibit the Board from leasing any Unit owned by the Association or any Unit which the Association has been issued an Order of Possession by the Circuit Court of Cook County.
- Except as expressly set forth herein, the Declaration shall remain in full 2. force and effect in accordance with its terms. Atlest:
