- 8. **Fees.** Lender may collect fees and charges authorized by the Secretary.

"Current Index" means the nost recent Index figure available 30 days before the Change Date. If the Index (as defined above) is no longer a ailable, Lender will use as a new Index any index prescribed by the Secretary. As used in this Rider, "Secretary" means the Secretary of Housing and Urban Development or his or her designee. Lender will give Borrower notice of the new Index.

#### (C) Calculation of Interest Rate Changes

Before each Change Date, Lender will calculate a new interest rate by adding a margin of Two and

#### One Quarter

2.2500%) to the Current Index and rounding the sum to the nearest one-eighth of percentage points ( one percentage point (0.125%). Subject to the limits stated in Paragraph (D) of this Rider, this rounded amount will be the new interest rate until the next Change Date.

### (D) Limits on Interest Rate Changes

The existing interest rate will never increase or decrease by more than one percentage point (1.0%) on any single Change Date. The interest rate will never be more than five percentage points (5.0%) higher or lower than initial interest rate.

#### (E) Calculation of Payment Change

If the interest rate changes on a Change Date, Lender will calculate the amount of monthly payment of principal and interest which would be necessary to repay the unpaid principal balance in full at the maturity date at the new interest rate through substantially equal payments. In making such calculation, Lender will use the unpaid principal balance which would be owed on the Change Date if there had been no default in payment on the Note, reduced by the amount of any prepayments to principal. If the monthly payment amount calculated in accordance with Paragraph (E) of time R der decreased, but Lender failed to give timely notice of the decrease and Borrower made any monthly payin amounts exceeding the payment amount which should have been stated in a timely notice, then Borrower bar the option to either (i) demand the return to Borrower of any excess payment, with interest thereon at the Notorale (a rate equal to the interest rate which should have been stated in a timely notice), or (ii) request that any excess payment, with interest thereon at the Note rate, be applied as payment of principal. Lender's obligation to return any excess payment with interest on demand is not assignable even if the Note is otherwise assigned before the demand for return is made.
