This Subordination Agreement, made in the City of Oak Lawn, State of Illinois this 20th day of June, 2003 by George Washington Savings Bank, organized and existing under and by virtue of the laws of the United States of America and doing business in the State of Illinois ("Bank")

Whereas, the Bank is the owner of a mortgage dated November 1, 2002 and recorded December 11, 2002 among the land records in the Office of the Recorder of Deeds of Cook County, Illinois as document number 0021365127 and made to CAHAL BYRNE AND THERESA BYRNE, HUSBAND AND WIFE, IN JOINT TENANTS ("Borrowers"), to secure and indebtedness of \$96,500.00 ("Mortgage"); and

NOW, THEREFORE, in consideration of the sum of Ten (\$10,000) Dollars in hand paid by each of the parties hereto to the other, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and in order to induce Mortgagee make the loan to Borrowers, in and by mutually agreed, as follows:

That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of the Mortgagee's mortgage dated _____ reflecting and securing the loan made by Mortgagee to Borrower, in the amount of One Twenty Two Thousand Dollars or a 100's and to all renewals, extensions and replacements of said Mortgagee's mortgage; and

2. That this Agreement shall be binding upon and shall insure to the benefit of Mortgagee, its successors and assigns.
