EXHIBIT A

Legal Description of the Property

That part of the Southeast ¼ of the Northeast ¼ of Section 16, Township 41 North, Range 11 East of the Third Principal Meridian described as follows:

Beginning at Northeast corner of said Southeast 1/4 of the Northeast 1/4 and running thence West along the North line of said Southeast ¼ of the Northeast ¼ a distance of 722.0 feet to the center line of Allington Heights Road; thence Southwesterly along said road center line a distance of 244.96 feet; innece East along a line forming an angle of 90 degrees with the last described line a distance of 90 58 feet; thence East along a line parallel with said North line of the Southeast ¼ of the Northeast 1/4 a distance of 422.74 feet to the intersection of said line with the East line of said Southeast 1/4 of the Northeast 1/4; thence North along the East line of said Southeast 1/4 of the Northeast 1/4 a distance of 333.69 feet to the Point of Beginning all in Cook County, Illinois.
