## ASSIGNMENT AND REDESIGNATION OF LIMITED COMMON ELEMENTS

THIS ASSIGNMENT AND REDESIGNATION OF LIMITED COMMON ELEMENTS (this "Assignment") is made as of this **T** day of August, 2003, by South Campus Development Team, L.L.C., an Illinois limited liability company ("SCDT"), as Declarant and ("Owner") as fee owner of that certain Unit as hereinafter described.

### **RECITALS**:

- A. SCDT is the Declarant under that certain Second Amended and Restated Declaration of Condominium for The University Village Lofts, dated as of July 16, 2003, and recorded July 17, 2003 as Document No.0319810029, as amended from time to time (the "Declaration"), which governs certain real property legally described therein. Capitalized terms not expressly defined herein shall have the meanings ascibed to such terms in the Declaration.
- **B.** As of the date hereof, SCDT is the fee owner of that certain Unit designated on the Plat as Unit 606-P, more particularly described on Exhibit A artached hereto (the "Unit").
- C. Pursuant to the Declaration, the Parking Space designated on the Plat as B44-P is currently designated as a Limited Common Element appurtenant to Unit 6%-F.
- **D.** Pursuant to the Declaration, the Parking Space designated on the Plat as G15-P is currently designated as a Declarant Parking Space.
- E. Under the terms of Section 3.7(c) of the Declaration and otherwise in accordance with the terms of Section 26 of the Condominium Property Act of the State of Illinois (the "Act"), SCDT and Owner desire to assign the foregoing Limited Common Element Parking Space and Declarant Parking Space as more particularly described hereunder.
- NOW, THEREFORE, in consideration of the recitals set forth above and the mutual covenants and agreements hereinafter set forth, and for Ten and No/100 Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, SCDT, as Declarant and as fee owner as set forth above, declare as follows:

- 1. SCDT, as the fee owner of Unit 606-P, hereby assigns, conveys, transfers and sets over unto SCDT, as the Declarant, all of its right, title and interest under the Declaration with respect to the Parking Space designated as B44-P, such that Parking Space B44-P shall hereafter be deemed a Declarant Parking Space.
- 2. SCDT, as Declarant, hereby assigns, conveys, transfers and sets over unto Unit 606-P, all of its right, title and interest under the Declaration with respect to the Parking Space designated as G15-P, such that Parking Space G15-P shall hereafter be a Limited Common Element appurtenant to Unit 606-P.
- 3. In accordance with Section 26 of the Act and Section 3.7(c) of the Declaration SCDT hereby certifies that a copy of this instrument has been delivered to the Board. For purposes of Section 3.7(c) of the Declaration and Section 26 of the Act, this instrument shall constitute an amendment to the Declaration for the limited purposes described in this Assignment. Nothing contained herein shall modify the Undivided Interest appurtenant to the Units.
- 4. This A signment shall be binding upon and shall inure to the benefit of the fee owner of the Unit and its successors and assigns with respect to the foregoing Unit.
