NGW THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to 765 P.CS 605/26, it is hereby agreed as follows:

#### Recitals

- 1. The recitals are incorporated hereby by reference. All capitalized terms used herein shall have the same definition as set forth in the Declaration, unless otherwise defined herein.
- 2. Unit 4 Owner hereby transfers, assigns, and sets over unto the Unit 3S Owner all of Unit 4 Owner's right, title, and interest in roof area "A", it being the intention of the parties that the aforesaid limited common element shall hereafter be assigned to the exclusive use of Unit Owner 3S, and its successors and assigns.
- 3. The aforesaid transfer of the limited common elements does not change the proportionate shares of Unit 3S and Unit 4 respectively in the common elements.
- 4. Unit 4 Owner and Unit 3S Owner hereby certify that a copy of this Amendment has been delivered to the Board of Directors of the 3351 North Seminary Condominium Association.
