

## ILLINOIS' STATUTORY SHORT FORM POWER OF ATTORNEY FOR PROPERTY

(NOTICE: THE PURPOSE OF THIS POWER OF A'ITORNEY IS TO GIVE THE PERSON YOU DESIGNATE (YOUR "AGENT") BROAD POWERS TO HANDLE YOUR PROPERTY WHICH MAY INCLUDE POWERS TO PLEDGE, SELL OR OTHERWISE DISPOSE OF ANY REAL OR PERSONAL PROPERTY WITHOUT ADVACE NOTICE TO YOU OR APPROVAL TO YOU. THIS FORM DOES NOT IMPOSE A DUTY ON YOUR AGENT TO EXRCISE GRANTED POWERS.
