BUILDING NO. 5, UNIT NO. 404-A IN THE DANA POINT CONDOMINIUM, AS DELINEATED ON SURVEY OF THE FOLLOWING DESCRIBED PARCEL OF LAND (HEREINAFTER REFERRED TO AS "PARCEL"): LOTS 'B' AND 'C' TAKEN AS A TRACT, (EXCEPT THE NORTH 306.0 FEET OF THE WEST 350.0 FEET AND EXCEPT THE NORTH 469.65 FEET LYING EAST OF THE WEST 350.0 FEET THEREOF) IN KIRCHOFF'S SUBDIVISION, BEING A SUBDIVISION IN SECTIONS 10 AND 11, TOWNSHIP 41 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, AND SECTION 33, TOWNSHIP 42 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT OF SAID SUBDIVISION RECORDED MAY 22, 1917 IN BOOK 152 OF PLATS, PAGE 15, IN COOK COUNTY, ILLINOIS: WHICH SURVEY IS ATTACHED AS EXHIBIT A TO THE DECLARATION OF CONDOMINIUM OWNERSHIP MADE BY LASALLE NATIONAL BANK, AS TRUSTEE UNDER TRUST NO. 22370 AND RECORDED SEPTEMBER 8, 1978 AS DOCUMENT NO. 24,618,528 TOGETHER WITH THE UNDIVIDED PERCENTAGE INTEREST APPURTENANT TO SAID UNIT IN SAID PARCEL (EXCEPTING FROM SAID PARCEL ALL THE PROPERTY AND SPACE COMPRISING ALL THE UNITS THEREOF AS SET FORTH AND DEFINED IN SAID DECLARATION AND SURVEY).

and in connection therewith and as part thereof, states as follows: That on and prior to August 8, 2003, Christopher J. Policht (a bachelor) was/were the owner(s) of the legally described property which is also commonly known as 1615 E. Central Road #404A, Arlington Heights, Illinois, and received and benefited from Property Maintenance provided by the Village of Arlington Heights and thereby incurred a total charge of \$ 1,497.15 from the Village of Arlington Heights, which became due and owing on August 25, 2003 by virtue of account statements rendered on said date, said account became delinquent, in accordance with the ordinance of the Village of Arlington Heights.

That there is still due, unpaid and owing to the Claimant the balance of \$ 1,497.15 for which, with costs of \$ 100.00, the Claimant claims a lien on said land and improvements in the total sum of \$ 1,597.15.

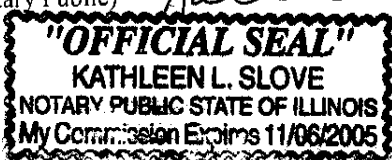
