# LEGAL DESCRIPTION

parcel 1:

lots 1, 2, 3, 4 and the west 9 feet of lot 5 and the west 1.69 feet of lot 41 in block 1 in Fullerton's Third Addition to Chicago being a subdivision of that part of the northeast 1/4 of section 31, township 40 north, range 14, east of the third principal meridian, in Cook County, Illinois, lying north and east of the north branch of the Chicago River.

also

lots 42, 43, and 44 in the resubdivision of lots 42, 43, and 44, the vacated alley north of and adjoining the same and of the east 16 feet of lot 5 in block 1 in Fullerton's Third Addition to Colcago aforesaid (excepting from said lot 42, the north 16 feet of that part thereof 17275 east of the west line of the east 16 feet of lot 5 produced south in block 1 of Fullerton's Third Addition to Chicago heretofore mentioned), in Cook County, Illinois.
