(D) Limits on Interest Rate Changes

The interest rate I am required to pay at the first change Date will not be greater than 9.595% or less than 2.000%. Thereafter, my adjustable interest rate will never be increased or decreased on any single Change Date by more than one percentage point (1.000%) from the rate of interest I have been paying for the preceding six months.
