SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT, made in the city of Valparaiso, State of Indiana this /J day of August by Glenn J. Tabor.

WITNESSETH

WHEREAS, Glenn J. Tabor covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated reflecting and securing the loan made by Mortgagee to August 25, 2003 Borrower, in the amount of \$ 449,000.00 Dollars, and to all renewals, extensions or replacements of said Mortgagee's mortgage; and

2. That this Agreement shall be binding and shall inure to the benefit of Mortgagee, its

successors and assigns.
