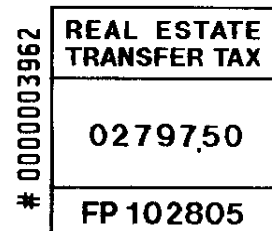
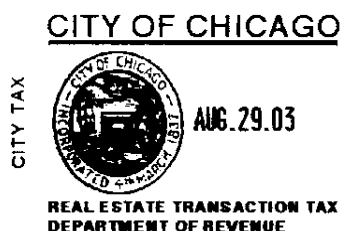
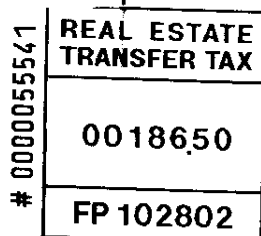
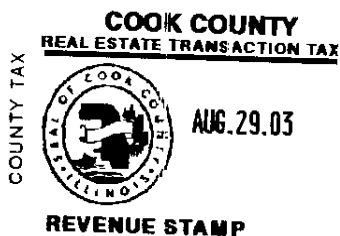
PARCEL 2: THE EXCLUSIVE RIGHT TO THE USE OF P-49 AND SG-18, LIMITED COMMON ELEMENTS AS DELINEATED ON THE SURVEY ATTACHED TO THE DECLARATION OF CONDOMINIUM AFORESAID.

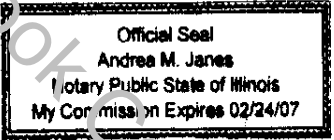
