THIS INDENTURE WITNESSETH, That the Grantor(s), Genevieve I. Siwinski of 18229 Michigan Court in Orland Park, Illinois 60467 in the County of Cook and in consideration of Ten -----(\$10.00)----- Dollars, and other good and valuable considerations in hand, paid, Convey(s) and Warrant(s) unto the **PALOS BANK AND TRUST COMPANY**, an

Illinois Banking Corporation of the United States of America, as Trustee under the provisions of a Trust Agreement dated the 30th day of July, 2003 and known as Trust Number 1-5791 the following described real estate in the County of Cook in the State of Illinois to wit:

All persons and corporations whomsoever and whatsoever shall be charged with notice of this condition from the date of the filing for record of this Deed.

Any the said Grantor(s) hereby expressly waive(s) and release(s) any and all right or benefit under and by virtue of any and all statutes of the State of Illinois providing for the exemption of homesteads from sale on execution or otherwise.

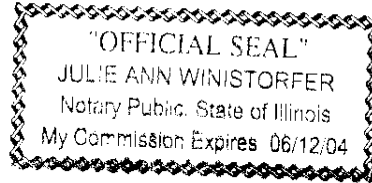

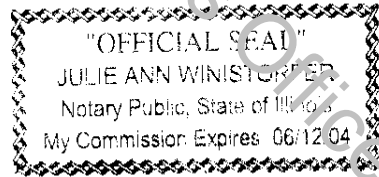
