This Power of Attorney is specifically limited to the above purposes and, if not exercised prior to AUGUST 18, 2003, shall be revoked.

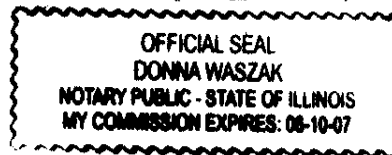
